Where Housing is Winning

In 2025, YIMBY Action chapters won 196 state and local policy victories.

Seattle: A Clean Sweep

Chapter: Seattle YIMBY

Winning elections is extremely fun – especially when all of Seattle YIMBY’s endorsed candidates won in the November election. Katie Wilson won the Seattle mayoral election; Eddie Lin in City Council District 2; and Alexis Mercedes Rinck in District 8 (at-large). Seattle also passed Proposition 1A which raises money for social housing through a local tax on payrolls of over \$1 million.

Hawai’i: Saying ‘Ae to Transit-Oriented Development

Chapter: Hawai’i YIMBY

The YIMBY movement in Hawai’i continues to make steady progress, celebrating bills like H.B. 1409, which provides generous incentives to cities to allow apartments near transit stops and prioritizes affordable housing funding in transit-connected areas.

Bend: Bringing Back Row Houses

Chapter: Central Oregon YIMBY

Bend, Oregon updated its development code to allow detached townhomes, or row houses. This classic housing type creates smaller, more attainable homes that can serve as starter homes or aging-in-place options—expanding the range of housing choices in Bend’s growing market.

Tucson: Chapter Founder Elected to City Council

Chapter: Tucson for Everyone

Our local chapter founder, Miranda Schubert, was elected to city council in a big win. Tucson also achieved two citywide rezonings, one which allows for denser transit-oriented development on lots near major transportation routes and a missing middle reform that will allow up to four units on ALL residential lots in the city (minus a few horse ranches).

Denver: Opening the Door to Single-Stair Apartments

Chapter: YIMBY Denver

Denver took a step toward modernizing its building code by advancing legislation to allow single-stair apartment buildings—a design common internationally but long restricted in many U.S. cities. The change makes it easier to build small and mid-sized apartments that fit into existing neighborhoods while lowering construction costs, helping expand attainable housing options across the city.

Asheville for All: Big Wins at the City Council

Chapter: Asheville for All

YIMBYs lobbied the city council to make it easier for developers to build more multifamily housing, promote more walkable environments, encourage more bicycle parking, and reduce car parking. And in March the council voted yes!

Orlando: Planning for Homes in Vision 2050

Chapter: Orlando YIMBY

YIMBY leaders helped shape Orange County’s Vision 2050 comprehensive plan, ensuring the region’s long-term growth strategy includes room for more homes near jobs, transit, and community services. Embedding pro-housing principles in the county’s guiding plan lays the foundation for a more affordable housing future.

Alexandria: Moving Affordable Homes Forward

Chapter: YIMBYs of NOVA

Alexandria’s 2025 city budget included \$3 million in new funding to move previously approved affordable housing developments closer to construction. The city also funded a study for a potential local housing voucher program, while advocates continue pushing cost-free reforms like removing parking mandates to make it easier to build more homes.

Less Parking, More Homes

Outdated parking policies inflate construction costs and suppress housing supply. In 2025, YIMBY Action chapters supported reforms that reduce or eliminate parking requirements near transit. Volunteers helped shift support from cars to homes resulting in zoning changes that will make homes more affordable and smaller infill projects more attainable.

Parking Reform Wins

Abundant Housing Illinois

Chicago eliminated minimum off-street parking requirements for most new development near transit, letting builders provide no required parking by right.

The Illinois General Assembly adopted the People Over Parking Act, banning local parking minimums for projects near transit statewide.

Asheville for All

Asheville amended its Unified Development Ordinance to remove minimum off-street parking requirements in many areas, encouraging more walkable and transit-oriented development.

Dallas Neighbors for Housing

Dallas City Council overhauled the decades-old parking code, cutting or eliminating minimum parking requirements downtown, near transit, and for many commercial and residential uses.

Seattle YIMBY

SB 5184 was passed which limits, and in some cases eliminates, the number of parking spaces cities can require for new developments.

YIMBY Denver

Denver eliminated citywide parking minimums under Colorado House Bill 24-1304, cutting housing costs and unlocking more homes, especially near transit.

The reforms will lead to more affordable housing, more livable neighborhoods, and a better Dallas for generations to come.”

How Grassroots Advocacy Propelled SB 79 in California

“SB 79 required all hands on deck to get it across the finish line.”

Had it lost a single vote during any step, it wouldn't have passed. While the bill is now state law, the work's not done. We need to counter attempts to spread misinformation about the bill's impacts, and get ahead of attempts to water it down via legislative poison pills. I helped host educational events this year talking through what the bill does and why it's so necessary to build more homes in the Peninsula, to help ensure support on the ground for the bill, and that further reforms to housing policy remain strong.”

“We are not building nearly enough housing in Los Angeles. The passage of SB 79 has pushed us to truly engage with a goal we claim to have as a city—transit lines with lots of housing around them—through our local implementation plan.”

SB 79 was the third iteration of a bill that upzones parcels near transit, and it had razor-thin margins on every vote. One of the reasons it ultimately passed was because YIMBY Action built and deployed real political power.

Throughout the legislative session, YIMBY Action chapters activated a disciplined statewide base to generate constituent pressure in key districts, deliver coordinated testimony, and shore up pro-housing champions at pivotal moments.

Behind the scenes, YIMBY Action staff and volunteer leaders aligned messaging across our coalition and translated complex land use concepts into clear calls to action. The result was a visible pro-housing constituency that gave legislators the cover to advance a bill that will unlock more homes in high-opportunity communities.

Enforcing the Laws that Make Housing Possible

Passing pro-housing laws is only the first part of the battle. That's why YIMBY Law fights to ensure cities across the country fairly and legally implement new and existing housing supply laws. In 2025, YIMBY Law led numerous legal battles to take down antiquated housing policies, enforce housing supply opportunities, and ensure new homes are going up in high-opportunity areas.

Last year, YIMBY Law:

Sued to defend SB 9 after executive actions threatened to block duplexes and lot splits in LA wildfire rebuilding areas to protect equitable recovery and prevent wealthy enclaves from opting out of housing.

Challenged emergency powers abuse that would have let local governments sidestep state housing law under the guise of safety, reinforcing legislative authority and statewide consistency.

Expanded implementation and enforcement nationally with the support of a new Robert Wood Johnson Foundation health-equity partnership to target exclusionary, high-opportunity communities still resisting new homes.

The 22-story mixed-use tower features 303 rental units. Its innovative use of state density bonus laws and commitment to workforce housing have earned it recognition for advancing inclusive and sustainable urban development. The project broke ground in November 2025.
